THIRD QUARTER 2021 ASSESSMENT:

- The portfolio underperformed the policy benchmark for the quarter as markets stalled following a strong rally in the first half of the year. Underperformance was largely driven by marketable alternatives, which detracted ~110 bps of value over the HFRI Diversified Index. Performance from the global equity (-0.2% vs. -1.1% for the MSCI ACWI Index) and the emerging markets portfolio (-3.7% vs. -8.1% for the MSCI Emerging Markets Index) were particularly strong on a relative basis. These returns do not include performance for private investments, which will report results over the next several weeks as is typical.*

TRAILING 1-YEAR ASSESSMENT:

- NHCF (+27.8%) outperformed the policy benchmark (+21.5%) for the trailing 1-year (with private investments held at 0% from July 1, 2021 – September 30, 2021). The public equity portfolio (+32.3%) drove performance on a relative and absolute basis, outperforming the blended equity benchmark by +430 basis points.
