These impact investments, which provide low-cost capital to community projects and organizations in New Hampshire, will produce below-market returns but promise significant local impact.<sup>4</sup></p>	<p>For those who want liquidity for maximum short-term grantmaking flexibility, the short-term pool keeps your fund in cash or cash equivalents, such as money markets and certificates of deposit.
