Special circumstances for check-in

Certain passengers cannot check in online or through the app and must see a Delta agent at the airport ticket counter for document verification. This includes:

- **International travelers who need to have their passport and visa (if required) verified. This is especially true for your first flight with Delta.**
- **Passengers traveling with infants.**

What to do after checking in

What is the 62 inch rule for Delta?

Silver Medallion Members who hold an eligible Delta SkyMiles American Express Card will receive a second bag free (up to two free bags at 70 lbs. or 32kg each) for travel within the U.S. and Canada. Baggage size must not exceed a length + width + height for a total of 62 linear inches (157 cm).

The Delta 62-inch rule refers to the maximum linear dimension for a standard checked bag, which is the sum of its length, width, and height. This limit is 62 inches (157 cm), and standard checked bags must also not exceed 50 pounds (23 kg). Exceeding the 62-inch limit will result in an oversize fee, which can vary depending on the destination. Calculation: Add the length, width, and height of your bag together. For example, a suitcase that is (26 inches) long, (20 inches) wide, and (16 inches) deep totals (62 inches) ($26+20+16=62$). Weight: Bags heavier than 50 pounds are subject to overweight fees, even if they are under the 62-inch linear limit.
